#### **General Information**

Main field: Technology. Elective Compulsory for: L3

Language of instruction: The course will be given in Swedish

#### **Aim**

The course aims to provide the students with basic knowledge of the Swedish judicial system in the area of environment. Students will not only be able to develop skills in identifying and applying current law rulings but also provide them a broad comprehension of the judicial structure of law that will serve as an important tool for Civil Engineers to solve practical legal problems in business, public service and local governments.

# Learning outcomes

Knowledge and understanding
For a passing grade the student must

- be able to identify relevant legal issues within this area.
- be able to analyze environmental problems that may arise.
- be able to identify adequate environmental regulations.

Competences and skills

For a passing grade the student must

• be able to read and understand applied social order and justice rulings.

- be able to evaluate consequences of straightforward environmental issues.
- be able to propose or recommend adequate solutions to straightforward environmental issues.

Judgement and approach

For a passing grade the student must

- be able to evaluate the consquences of environemental issues
- have knowledge of the role of environmental law in society
- be abel to indentify the personal need for further knowledge and competence within the area of environmental law

#### **Contents**

The aim of this course is to provide the students with basic knowledge of the Swedish legislation on land use, use of natural resources and preservation of the natural environment. The case studies are designed in such a way that students can put into practice existing judicial rulings in relation to the different common interests of the society. Special emphasis is placed on reading and understanding legal texts.

#### **Examination details**

**Grading scale:** TH - (U,3,4,5) - (Fail, Three, Four, Five)

**Assessment:** The student has to complete a written assignment and oral presentation of said assignment as well as take a written exam. The written assignment has to be passed before the student is allowed to take the exam.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.
