## **General Information**

### Aim

The course aims to provide students in Industrial Design with basic knowledge and understanding of Design History, the history of Industrial Design in particular.

# **Learning outcomes**

*Knowledge and understanding*For a passing grade the student must

- Have basic knowledge of design history, particularly history of industrial design, and have knowledge of its stylistic and fashion related connections to visual culture in general
- Be familiar with design as an expression of technical and industrial development.
- Have knowledge of the history of the professional role of the designer.

Competences and skills
For a passing grade the student must

- Be familiar with basic methods of studying design history.
- Be able to discuss design history both orally and in writing.

Judgement and approach
For a passing grade the student must

 Be able to relate design history to various social and cultural contexts; power, gender and ethnicity are to the student obvious and fundamental aspects in the study of design history.

### **Contents**

#### 1. Structure

Instruction consists of lessons and seminars were the students also are given possibilities to discus their own ongoing projects in a critical context.

#### 2. Content

The course presents an outline and a problematisation of Western design history. A multitude of different types of designed objects are studied. They are discussed in relation to the cultural context in which they were made, in relation to the history of art, in relation to individual designers. Design is also related to conditions of power, ethnicity and pluralism. Matters of experiencing, describing, analysing, and interpreting design are essential.
